

**New rates for roaming calls to value-added (VAS) service numbers
(only for new Scarlet customers subscribing after 12 July 2023 and
customers who have been informed of the transfer of their data to
Proximus IT infrastructure)**

From 1 January 2024 on, when roaming, a single, transparent per-minute rate per zone to any VAS number, instead of variable rates from €0 to €12.10 incl. VAT /min incl. VAT) set by the operator of the country visited.

- From the EU zone and Zone 1: €3/min incl. VAT
- From the Exception zone: €6.17/min incl. VAT
